### What is the Purpose of the Asylum Interview?

Do you meet U.S. legal requirements for asylum?

Your chance to tell your story to the Asylum Officer

Helps Asylum Officer make a decision on your case





### What is the Asylum Office? Who is the Asylum Officer?





U.S. Citizenship and Immigration Services





### **Getting to the Asylum Office**

Metal detector and bag scan

Waiting in waiting room

Fingerprints and photo taken

Asylum Officer will call you by the last three digits of your "A number"







### Who Must Come to the Interview?

### "Principal applicant"

Person whose name and information is at the top of I-589 asylum application

## Spouse and children who are in the United States

Marked as INCLUDED on form I-589

Legally married for spouse

Children - unmarried and under 21







**UPDATE**: <u>As of September 13, 2023</u>, the Asylum Office requires <u>ALL</u> applicants to **bring their own interpreters** 

Your interpreter **MUST** attend the interview **IN PERSON** 

**NO** interpreters by telephone are allowed!





### Who Can Be an Interpreter?

#### **MUST BE:**

Fluent in Dari/Pashto and English 18 or older

#### **MAKE SURE:**

Your client and the interpreter understand each other!

#### **MAY NOT BE:**

Family member who is a derivative on the case or a witness in the case

Someone with an asylum application who did not yet attend their own interview

A representative or employee of the Afghan government

The attorney or accredited representative





### How to Work with an Interpreter

Say 2 or 3 sentences and then pause to let interpreter translate

REMEMBER: <u>The interpreter is a human - not a computer</u>

Interpreter must only interpret what is said by the applicant(s) and the officer. They must not add/change anything that is said. Must be NEUTRAL.

Asylum Officer will ONLY HEAR WHAT THE INTERPRETER SAYS IN ENGLISH





### What Questions Will the Officer Ask You?

Questions from form I-589

Questions about why you are afraid to return to Afghanistan

Questions about things that could bar you from asylum





### What Questions Will the Officer Ask Your Derivatives?

Your spouse and children will be asked about their identifying information and asylum bars

Your children will be asked asylum bar questions even if they are young

You as principal applicant cannot act as the interpreter for your spouse and children



### How to Respond to Asylum Officer

Tell the truth!

If you don't know something, tell the officer you don't know

If you don't remember something, tell the officer you don't remember

If you are not sure, tell the officer you are not sure

If you don't understand the interpreter, tell the officer!

You can ask for a break if you need a break





### **How Do I Prepare for the Asylum Interview?**

#### **Review your application**

**Review your declaration** 

Make a list of any changes

USCIS has 150 days from day you submitted I-589

Different possibilities:

Asylum granted Notice of Intent to Deny Denial
